About the School

The Balsillie School of International Affairs (BSIA) is an institute for advanced research, education, and outreach in the fields of global governance and international public policy.

As a hub in a global network of scholars, practitioners and students, the BSIA aims to develop new solutions to humanity's critical problems, improve global governance now and in the future, and enhance the quality of people's lives around the world.

Founded in 2007 by philanthropist Jim Balsillie, the BSIA is an equal collaboration among the Centre for International Governance Innovation (CIGI), the University of Waterloo (UW), and Wilfrid Laurier University (Laurier). The collaborating institutions bring to the BSIA different but complementary strengths, so they have different roles and responsibilities.

The two universities employ BSIA faculty and offer BSIA's academic programs, while CIGI, as a think tank, uses its in-house expertise and its worldwide network of practitioners to help inform and guide BSIA's outreach and collaborative research. The BSIA is also the home to four research centres with an international profile - the International Migration Research Centre; the Laurier Centre for Sustainable Food Systems; the Canadian Network for Research on Terrorism, Security and Society; and the Hungry Cities Partnership.

The unique integration of the collaborating institutions' approaches and cultures gives BSIA an unmatched ability to promote vigorous engagement across boundaries of discipline and practice, to connect today's experts with tomorrow's leaders in critical debate and analysis, and to achieve—in all its work—the highest standards of excellence.

Highlights of the Year

The year 2021 will be remembered for the collective need to navigate uncertain space and to learn to continue living in a COVID-impacted world. The BSIA is grateful for everything that its wonderful community did to come together, physical limitations and boundaries notwithstanding, and demonstrate such strong levels of resilience and strength during a critical time when the health and well-being of our community remained paramount. In this context, the work of the BSIA COVID Task Force, in close

collaboration with its counterparts at University of Waterloo, Wilfrid Laurier University and CIGI, was invaluable.

In September 2020, we were delighted to welcome a large cohort of MIPP, MAGG and PhD students – a cohort which became known as our “Zoom cohort”. The entire program, and the mainstay of their student experience, was online. Mr. Jim Balsillie, the School’s founder and donor, presided as keynote speaker at the students’ virtual orientation day.

This year paved the way for the implementation of year two of the BSIA’s 5-year Strategic Plan. These plans involved the further strengthening of our institutional relationships and communications channels with all collaborative partners. Amongst other cross-institutional projects, a number of BSIA faculty supported a large CIGI-led project entitled “Reimagining A National Security Strategy for Canada”.

We were also informed in May of the welcomed and long-awaited news that we had been granted affiliate status by the Association of Professional Schools of International Affairs (APSIA). This membership enables the BSIA community to benefit from APSIA’s vast resources and services, and allows us to share a table with esteemed global ivy league schools. An important initiative proposed in our strategic plan was the launch of the inaugural annual Balsillie Lecture. The annual Balsillie Lecture hosts distinguished scholars and writers whose work influences thinking on critical challenges to humanity. Our community was delighted to host Professor Margaret MacMillan (University of Oxford) as the BSIA’s inaugural Balsillie Lecturer.

The BSIA staff team ushered in the development of a separate (and quite slick!) website for the Balsillie Papers. The new Balsillie Papers’ website now emulates that of a more professional peer-reviewed publication which is supported by both DOI and e-ISSN numbers, and includes a podcast. We were thrilled to find out that the website won two awards in the 2020 MarCom Awards program: a Platinum Award in the Microsite category, and a Gold Award in the Website Design category.

The School also inaugurated the Balsillie Executive Institute, which was developed as a separate entity to the School in order to provide a platform for a future-oriented provision of career-focused professional training in the areas of policy and governance. The School’s Executive Short Course Committee approved six new executive short courses led by BSIA faculty and fellows. The first course was delivered online in March 2021.

Our commitment to professional development was also reflected in a suite of short course training which the School arranged for all students. This training included Monitoring and Evaluation, Building a Social Media Profile, Preparing for Virtual Interviews, Media Training, and more.

The work of the School’s research clusters continued apace and included the hosting of renowned speakers presenting on important issues in the international public policy and global governance space. These speakers included Ambassador Nasise Challa Jiri, Ethiopian

Ambassador to Canada; Ambassador Jacqueline O'Neill, Canada's first Ambassador for Peace and Security; and Dr. Rohinton Medhora, President of CIGI. The School also hosted its first Critical Conversations event which was based on a newly found partnership between the BSIA and the Canadian Ditchley Foundation. The event featured John Hancock (World Trade Organization), Diana Fox-Carney (Climate Policy Expert) and William White (former OECD and Bank of Canada) all of whom engaged in a well-attended discussion entitled "Building Resilient Futures: COVID, Climate and the Economy".

We were extremely welcoming, and proud, of the student volunteers who joined the BSIA's Anti-Oppression and Equity Committee. It was an important year for the School to further develop its policies and programs according to the wider mandate of the Committee which is meant to complement the good work of the universities' equity and diversity offices. One of the biggest highlights of the academic year was the student-led initiative held in May entitled "Hadithi Hadithi" ("Stories that remind you of home"). The event brought students, faculty, fellows and staff together and was led by a number of student presenters.

We were also pleased to welcome the creation of the Global Climate Action Committee. Led by Dr. Derek Hall, and comprised of faculty, staff and students, the Committee has taken on the responsibility of drafting the School's Net Zero Greenhouse Gas Emissions Plan. The hope is that the Committee will have the plan drafted and approved by BSIA Council and the BSIA Board in time to join the Race to Zero for Universities and Colleges in the fall. To help the work of the Committee along, the School has also joined Sustainable Waterloo Region as a member.

This year's significant progress made by the BSIA could not have been possible without a dedicated and committed team of staff, faculty and fellows. We are grateful for the collective support provided to all BSIA students during the year, particularly in the context of our student mentoring program, GAC Fellowship projects, and the School's numerous voluntary committee and cluster leadership functions. In parallel to these efforts, and despite challenges posed by the pandemic, our faculty and fellows continued to perform consistently high in securing research grants (SSHRC Insight, Partnership and Connections; NSERC; and MITACS grants), fielding media commentary, winning book prizes, and publishing prolifically as evidenced by the many citations captured in later sections of this report.

Despite the ongoing uncertainties regarding COVID and global vaccination programs, I want to acknowledge the hard work of the entire BSIA community in making this another outstanding year for the School. I look forward to seeing what more we can accomplish next year.

Research Cluster Events

Every year, the Balsillie School hosts approximately 100 events, with almost half of those organized by the Research Clusters at the School. Each Research Cluster is assisted by a PhD candidate, who acts as the Support Officer for the cluster events along with the School's Events and Administrative Coordinator. The Support Officers also manage the research cluster webpages, and organize the cluster meetings. This year, all the events were hosted virtually, which opened up our audience reach significantly, as most cluster events are free and open to the public.
